 chair. During question-

hour on Education, Dr  
 Murad Rass said that  
 the government has  
 decided to enact a new  
 law to bring under its  
 purview private edu-  
 cational institutions  
 regarding their fees,  
 uniforms, syllabus and  
 other issues. The pro-  
 posed law would bar  
 the private education-  
 al institutions from  
 charging parent exor-  
 bitant fees.

He said had the  
 law been in place the  
 teacher who sexu-  
 ally harassed students  
 in Lahore Grammar  
 School would have

been behind the bars  
 instead of apologizing  
 for his highhanded-  
 ness. He lamented that  
 the PML-N remained  
 in power for 10 con-  
 secutive years but
